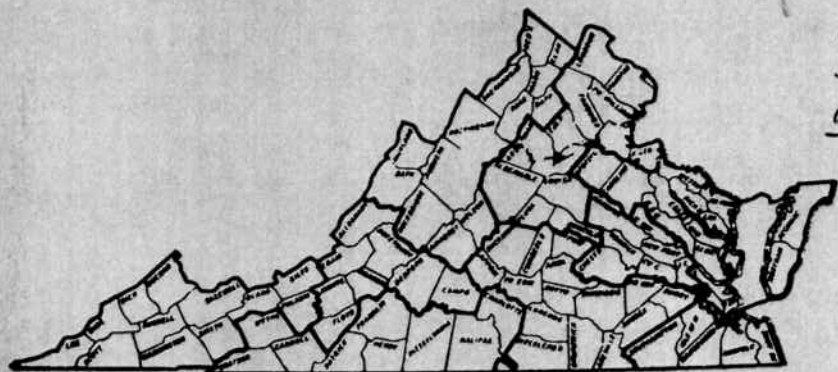

[P. 11] Richard Burks. £8.0.3½. Insolvent in 1783 and ever since.

George Banks & Stephen Neal. £18.11.8. This claim to be withdrawn.

Robert Byrd. £2.8.11. This claim to be withdrawn.

George Booker. £3.14.8½. Lives in Prince Edward; has sufficient estate to pay but denies the claim to be just.

Josiah Chambers. £72.2.7½. Debt paid since 1783; bond taken up.

Samuel Cunningham. £12.7.4. Removed to Georgia and had then sufficient estate to pay his debts.

[P. 12] John Cunningham. £12.12.11½.

Henry Caldwell. £8.5.6½. Paid the principal and removed to Kentucky with sufficient estate to pay his debts.

John Caldwell, F. Creek. £18.7.8. Dead; left estate which has been divided among his children and they have removed.

Ambrose Crawford. £7.14.3. Removed; had sufficient estate to pay all his debts.

James Carter. £31.14.11½. Removed to Georgia and died before 1783.

James Clark. £85.4.4 3/4. Insolvent in 1783 and ever since; still lives in Prince Edward.

[P. 13] William Carter. £0.11.7½. Still lives in Prince Edward; has sufficient estate to pay all his debts.

Charles Collier. £39.3.6. Dead; left sufficient estate in Prince Edward to pay all his debts.

Josiah Chambers. Settled his account 5 Feb. 1777 with James Cross, factor, and is indebted £72.2.7½. Settled in full with interest by Charles Allen, executor of Josiah Chambers, 20 March 1798.

[P. 14] David Cheatham. £1.0.3. Claim to be withdrawn.

Thomas Caldwell. £0.2.3½. Claim to be withdrawn.

Mrs. Sarah Cobbs. £0.14.11. Claim to be withdrawn.

Mrs. Ann Crockett. £31. Died on the parish. Claim to be withdrawn. Insolvent in 1783 and ever since.

Reuben Coleman. £75.18.9. Removed to Georgia; has a good estate there.

Mrs. Jean Daniel. £5.12.3½. Sufficient estate to pay all his debts.

[P. 15] James Daniel. £9.18.-. Paid since 1783. He lives in Prince Edward County.

William Davis, decd. £11.15.5½. The only person of this name I can hear of is an old man who still is alive in this county and able to pay his debts.

Daniel Davidson. £1.6.9½. Claim to be withdrawn. Removed before 1776 with his property.

Francis Drinkard. £5.16.6. Removed to Pittsylvania County.

Richard Davidson, decd. £6.10.3½. Died before 1783 and his family removed to Kentucky with sufficient estate.  
Templeton Davis. £3.19.2½. Lives in Charlotte County has sufficient property to pay his debts.

[P. 16] Abram Estis. £4.0.6. Removed to Kentucky; has property sufficient to pay his debts.

James Ewing Senr. £28.7.-. Dead; his children removed to Kentucky. He was insolvent in 1783 and ever since.

Daniel Eilbank's Estate. £21.11.5. Paid since 1783 Settled 25 Aug. 1776, with interest to be charged since the estate has considerable sums of money due in bonds bearing interest.

[P. 17] Joseph Fore. £34.8.2. Lives now in Prince Edward; sufficient estate to pay all his debts.

Capt. Thos. Flournoy. £22.11.1¼. The principal paid since 1783. Dead; left estate in Prince Edward now in the hands of John Purnell, executor, sufficient to pay all debts.

John Fielder. A very poor man in 1783; removed to Kentucky.

George Foster. £1.0.6. Claim to be withdrawn. He has a good estate in Prince Edward.

Thomas Fielder. £3.10.9. Claim to be withdrawn. Died before 1783; at that time and ever since his estate insolvent.

George Gresham. £52.11.4½. Removed; had sufficient estate to pay his debts when he removed to Georgia before 1783.

[P. 18] William Gauling. £3.2.1. Lives in Prince Edward County; has sufficient estate to pay his debts.

Samuel Goode Senr. £78.8.6. Paid since 1783.

Robert Goode. £18.1.3. Paid since 1783.

Alexander Gawling. £12.7.0. Paid £14.9.4 21 May 1798; bond given for balance, on which bond suit brought in Prince Edward County Court and the amount of judgment paid to Jno. Wilson, agent for the Company, by the hands of the Sheriff.

John Gauling's Estate. £28.10.2½. Estate in the hands of Alexander Gauling and others, his children, in Prince Edward County, sufficient to pay all his debts.

Patrick Gillespie. £8.16.1½. Paid in full; he lives in Prince Edward.

[P. 19] Thomas Green. £25.11.2½. Supposed not to have sufficient estate in 1783 to pay his debts.

Peyton Glenn. £7.0.0 3/4. He has James Cross's receipt in full, the payment made shortly after 1783. He lives in Prince Edward.

John Gillon. £8.3.2. Was insolvent in 1783 and continued so as long as he remained in this part of the country; has now removed to parts unknown.

Charles Gollohorn. £1.0.0. Claim to be withdrawn. Insolvent in 1783 and ever since.

Jerrard E. Gross and Charles Huds[on?] Senr. £2.6.0 3/4. Claim to be withdrawn.

[P. 20] Matthew Gale & John Mason. £25.14.2.

Capt. John Holcombe. £297.13.5½. Lives in Campbell County; was good in 1783 and having lately received a considerable legacy from a relation, it is believed that he is able to pay now.

Captain Phil. Holcombe. £86.18.3 3/4. He says he is entitled to a credit for one hogshead of rum of 116 gallons, a barrel of wine and some other articles returned which will nearly balance the account. James Cross made a memorandum to this effect in the books of the Company. Holcombe still lives in Prince Edward County; was sufficient to pay all debts in 1783 but perhaps his estate is not sufficient at this time, having given it to his children.

Charles Hudson. £20.2.6¼. Removed to Georgia with sufficient estate to pay his debts.

[Pp. 20-21] Benjamin Hawkins. £3.5.4. This debt was paid by Edward Haskins, his executor, who has receipt of John Wilson 21 May 1798.

[P. 21] William Hudson. £62.2.10¼. This debt, acknowledged by him 20 Dec. 1775 for £61.5.9 3/4 current money, was paid by John Hudson Junr., son of said William, deceased, who paid £41.5.0 in part 24 March 1796.

[P. 22] Charles Hudson Senr. £5.3.3½. This man was a Tory, joined the British Army in the time of the war and never returned.

Robert Hannah. £10.13.11.

Colo. Thomas Haskins. £115.1.5¼. This debt is paid.

David Hamlett. £1.0.4¼. Claim to be withdrawn. He lives in Prince Edward; has sufficient to pay all his debts.

Davis Hill. £4.16.1¼. The principal paid. He is dead; William Hill, his administrator, lives in Prince Edward.

Micajah Harris. £5.12.2 3/4. Dead; left sufficient estate. Munford Dejarnatt of Charlotte County married the widow who has part of the estate.

[P. 23] Mrs. Sarah Harrison. £13.2.5. Lives in Prince Edward; has sufficient estate to pay all her debts.

Giles Harris, decd. £5.9.9. Paid since 1783; good for all his debts.

Ezekiel Hendrick. £6.11.6. Removed with sufficient estate to pay his debts.

Ben. Hunt. £9.0.0½. Sufficient estate to pay all his debts.

William Hall. £9.9.9. Dead; left sufficient estate to pay his debts. There was suit in Prince Edward Court which abated by defendant's death and never arrived.

James Hurtfield. £3.19.10½. Claim to be withdrawn. He died and his estate was insolvent before 1783.

[P. 24] William Hansford. £8.8.3. Claim to be withdrawn; insolvent in 1783 and ever since.

Thomas Harris. [No entry]

Robert Johnston. £10. Paid since 1783; has sufficient estate to pay all his debts.

Henry Jones. £11.16.9¼. Paid in full. Bond in possession of Henry Jones of Prince Edward; £20.7.3 paid 18 June 1796.

William Kean, decd. £13.0.4½. Dead many years before 1783 and his estate in hands of William Carter of Prince Edward who is able to pay all his debts.

✓ [P. 25] Captain Peter LeGrand. £423.16.10¼. Removed to Kentucky. The mortgage of slaves which is recorded is for payment of £330.1.9 3/4 only and dated 20 Oct. 1774. It is believed when he removed to Kentucky he had sufficient property to pay this debt.

Colo. Robert Lawson. £239.19.8½. In 1783 he had property but not sufficient to pay all his debts then or any time since; now insolvent.

Maj. John Leneue. £259.7.5.½. Had not estate to pay his debts in 1783 or at any time since. Previous to the bill of sale which was taken to secure the debt, a mortgage had been given by Leneue to Buchanan, Hastie and Company on the same property, which has since been directed to be sold by a decree of the High Court of Chancery for the benefit of the first mortgagee.

[P. 26] Manoh Lasley. £27.17.4.

Benjamin Lawson. £18.10.6½. Not able to pay his debts in 1783 nor at any time since; now dead.

✓ Alexander LeGrand. £12.9.4. Paid since 1783; lives in Prince Edward; has sufficient estate to pay all his debts.

Nathaniel Lancaster. £50.10.9. Paid since 1783; lives in Prince Edward.

James Ligon. £9.8.-.

John Leigh. £6.10.7. Was insolvent in 1783 and ever since.

[P. 27] Richard Morton. £218.18.6. Removed to Kentucky. This debt has been paid since his removal.

Robert Martin, Wag<sup>r</sup>. £2.17.9.

John B. Mills. £9.8.6. Paid since 1783.

Robert Martin Jur. £15.0.1½. Removed to Georgia; carried with him a good estate.
