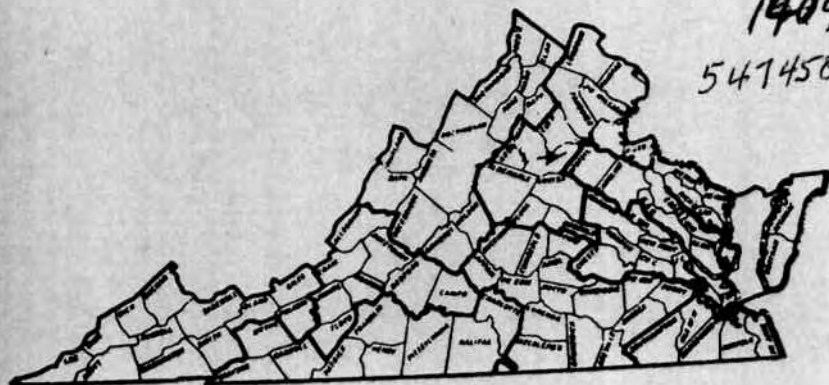

Daniel Ayres. £5.11.2. Has removed from Halifax to place unknown. He was always very poor and the debt always doubtful. It is supposed he was insolvent at the close of the war.

Francis Arnold. £16.14.3 3/4. Removed to Randolph Co., N.C. He was always poor and unable to pay the demand against him at the close of the war.

Baker Ayres. £3.0.6. Has always been insolvent, both before and since the war. He has either removed from Halifax or is dead.

John Boyd (son of Patrick). £31.2.8. Died solvent during the war. Who are his executors or administrators is unknown.

Patrick Boyd. £5.10.6 3/4. Died solvent. George Boyd Senr. is his administrator. The estate is sufficient to pay all his debts.

Benjamin Boxley. £9.10.5 3/4. Has always been able to satisfy the debt.

James Bailey. £12.5.10. Died during the war, solvent. His family has since removed to Georgia with his property.

Robert Bruce. £18.13.7. Died in Pittsylvania County. It is doubtful whether he was able to satisfy the debt at the close of the war.

[Pp. 90, 92-93] Thomas Buckingham. £2.12.9. Died in Tennessee in very good circumstances.

[Pp. 91, 93] Wright Bond. £35.18.0 1/4. Removed before the conclusion of the war to Holston. He was always poor and the debt always doubtful.

Samuel Burks. £0.5.11 1/2. Removed to North Carolina and has always been solvent.

David Bolling. £4.10.0. Has always been insolvent and unable to pay his debts.

Samuel Butler. £11.15.0 1/2. Died before 1783 in very doubtful circumstances.

Thomas Bowman. £1.13.1. Has always been able to pay his debts.

Thomas Blackstock. £2.11.3 3/4. Has always been able to pay his debts.

James Bruce. £9.0.6. Died in Pittsylvania solvent.

William Boyd. £2.10.3 3/4. Died solvent. Mary Boyd is his administratrix. The estate is now sufficient to pay his debts.
