PRICE¹

*1. JOHN¹ PRICE came to Virginia in the *Starr*, which sailed from England, 27 March 1611, and landed off Point Comfort, 22 May 1611. He was granted 150 acres in the Corporation of Henrico, 20 Feb. 1619/20.² His wife *Ann ____ had come in the *Francis Bonaventure* in Aug. 1620 and they were living at Neck of Land in Charles City, 1623/4,³ and 24 Jan. 1624/5, when he was listed as aged 40 and she as aged 21.

John¹ Price appeared as a witness before the General Court, 23 May 1625, and was a member of the Assembly which convened 10 May 1625 and drew up a protest to be sent to the King against any change in government.⁴ He died in 1628⁵ and his widow married (2) 1. Robert¹ Hallom (see HALLOM). On 6 March 1636/7 Richard Cocke patented 3000 acres "easterly upon the land granted to John Price now in the tenure of Robert Hallum."⁶ This land held by Mrs. Hallom was the original 150 acres granted to John¹ Price. Pursuant to the conditions of that grant her eldest son Mathew² Price on 23 May 1638 secured an additional 150 acres by patent:

Mathew Price sonn and Heire of John Price, late of Virginia, labourer ... one hundred and fiftie acres ... in the Countie of Henrico upon Turkey Island Creeke bounding East and by South upon the said Creek, West and by North towards Bremo and butting South and by West upon the lands graunted by pattent to his late Father John Price and now in possession of his mother Ann Hallom, widowe, towards the great river and soe runing and North and by East into the woods ... due ... in right of his said Father who had a pattent of one hundred and fiftie acres graunted 20th of February Anno Domini 1619 [1619/20] ... with condition upon planting the same to have it augmented and doubled ...⁷

Ann (____) Price Hallom married (3) Daniel Llewellyn (see PRICE

LLEWELLYN) and died before 1666.

Issue: *2. Mary², aged 3 months, 24 Jan. 1624/5; 3. Mathew², living 1638; died without issue; 4. JOHN².

4. JOHN² PRICE (John¹) married _____, daughter of John Wall.⁸ She apparently married (2) John Rowen, whose will, dated 1 May 1662,⁹ made bequests to his brother Henry Rowen, nephew John Rowen (son of Henry), and son Henry Rowen and recited:

I will likewise that my said brother shall have the bringing up of the two sonnes of the deceased John Price and the managing of there estates and that he will hereafter, when age of discretion shall be in them, to the utmost of his ability, teach or gett them to be taught to rite and read, in the meanwhile to bring them up in the fear of God. I doe give and bequeath unto the said two orphans, Daniel and John Price, one feather bed, rugge, bolster and blanket, the bed being that which they lye on and the rugge of a blue colour.

The fact that the sons of John² Price sold in 1677 the land which Mathew² Price had patented in 1638 shows that John² was the third child of John¹ Price.

Issue: 5. DANIEL³; 6. JOHN³.

5. DANIEL³ PRICE (John², John¹), born about 1654, with his brother John³ inherited the aforementioned 150 acres patented by Mathew² Price and sold the land, 1677, to William Hatcher. His son Benjamin Hatcher sold the tract, 18 Oct. 1681, to John Pleasants, the deed describing the plantation as "heretofore belonging to my father (which said land was by him purchased of Daniel and John Price in 1677), bounded by land of Samuel Woodward and downward upon Turkey Island Creek, containing 150 acres ... commonly known by the name of Turkey Island Point."¹⁰ A quitclaim deed to the tract given John Pleasants, 22 Dec. 1682, by Edward Hatcher, brother of Benjamin, further describes the land as "all that point and parcel of land called Turkey Island Point

... 150 acres."¹¹

Daniel³ Price signed the inventory of John Clayborne, 1 Feb. 1685/6.¹² His widow, Susan Price, was granted administration on his estate, 1 Aug. 1692.¹³ He married, after 23 July 1676, Susanna Carter, daughter of Giles Carter (1634-1701/2) of Henrico County and his wife Hannah Crew.¹⁴ Susanna married (2) Thomas Williamson who on 1 June 1696 at Henrico Court brought in William Sewell and Theodorick Carter (Susanna's brother) "who voluntarily offer them selves secu'ty for the Estate belonging to Danll. Price's orpts. in the hands of Thos. Williamson."¹⁵

Issue: 7. DANIEL⁴.

6. JOHN³ PRICE (John², John¹), born about 1656, sold his interest in the land inherited from Mathew² Price, 1677, as aforesaid. He was a planter of Martin's Brandon Parish, Charles City County,¹⁶ but subsequent to 1694 moved to Henrico County.

He married Jane Pew (or Pugh), daughter of Henry Pew of Henrico County and his wife Jane Womack.¹⁷ He left will 15 Dec. 1710-June 1711.¹⁸ His widow married (2) 9. Hugh³ Ligon (see HARRIS, Thomas).¹⁹

Issue: 8. MARY⁴; 9. JOHN⁴; 10. Daniel⁴, died by 4 April 1720 when a suit of Pew⁴ Price against John⁴ Price, heir at law of Daniel Price, was dismissed;²⁰ 11. PUGH [Pew]⁴; 12. Elizabeth⁴.

7. DANIEL⁴ PRICE (Daniel³, John², John¹), born about 1692, gave receipt,

Tabitha⁵, married 65. John⁵ Cox (see COX); 39. Elizabeth⁵; (by 3) 40. CHARLES⁵; 41. FRANCES⁵; 42. JUDITH⁵; 43. Jane⁵, born 26 Jan. 1760; 44. MARTHA⁵; 45. JOHN⁵; 46. 13. JOHN⁵ PRICE (Daniel⁴, Daniel³, John², John¹), of Henrico County, died 1781-83, leaving will proved 15 March 1783.⁴⁴ He was a tobacco inspector at Shockoe Warehouse. He married Mary ____.⁴⁵

Issue: 51. Samuel⁶, captain in Revolutionary War, left will 2 Nov. 1780-6 May 1782,⁴⁶ married Elizabeth Perriere [Puryear]; 52. James⁶, died 29 April 1802 at "Westwood," Henrico County, aged 60,⁴⁷ captain in Revolutionary War, for twenty years inspector of tobacco at Byrd's Warehouse, left will 7 April 1802-7 June 1802,⁴⁸ married Susannah Williamson Allen, who left will 2 Aug. 1822-3 Oct. 1825;⁴⁹ 53. Capt. Barrett⁶, born April 1749, died 4 Sept. 1794,⁵⁰ married, 25 Aug. 1771,⁵¹ 66. Sally⁶ Graves (see CROSHAW), who was born 1 Sept. 1756 in Goochland County and died 7 July 1852 in Henrico County;⁵² 54. John⁶, of Henrico County, left will 30 Dec. 1815-7 March 1816,⁵³ married Mary R. Lewis, who left will 1 Jan. 1820-8 Nov. 1821;⁵⁴ 55. William⁶, born 16 Sept. 1759, left will 14 Feb. 1825-6 July 1830,⁵⁵ of Richmond, married 1083. Sarah⁶ Lewis (see WOODSON), born 8 June 1772;⁵⁶ 56. Daniel⁶, said to have moved to Bedford County; 57. Capt. Elisha⁶, of Richmond, died 4 April 1809,⁵⁷ married

Annie ___, who died 20 Feb. 1802 near Richmond,⁵⁸ 58. Martha⁶, married (1), about 1762, Thomas Starke, who died before Oct. 1768 when administration on his estate was granted to Martha,⁵⁹ and (2), about 1768, John Hodges;⁶⁰ 59. Mary⁶, married John Leonard, who left will 5 Sept. 1780-5 Nov. 1782;⁶¹ 60. Sarah⁶, married John Williamson; 61. Catherine⁶, married ___ Wood.

14. DANIEL⁵ PRICE (Daniel⁴, Daniel³, John², John¹), of Henrico County, died before 1783.⁶² He was a tobacco inspector at Byrd's Warehouse and was a justice of Henrico County. He married Mary ___.

Issue: 62. Robert⁶, of Bedford County, left will 18 June 1816-24 June 1816,⁶³ married Mary ___; 63. John⁶, of Henrico County and later of North Carolina, married (1) Ann ___, who died 6 June 1787,⁶⁴ and (2) Frances ___; 64. Charles⁶, of Henrico County, given 400 acres by his father, 11 Feb. 1773,⁶⁵ married ___; 65. Joseph⁶, of Henrico County, left will 16 April 1802-10 March 1803,⁶⁶ married Lucy ___.

15. WILLIAM⁵ PRICE (Daniel⁴, Daniel³, John², John¹), of Charlotte County, left will 30 Aug. 1791-5 Jan. 1793.⁶⁷ He married Mary Williamson.

Issue: 66. Daniel⁶, of Halifax County, left will 3 March 1802-27 Feb. 1804,⁶⁸ married Lydia Morris; 67. Samuel⁶, left will 15 April 1801-7 Dec. 1801,⁶⁹ married Elizabeth ___; 68. William⁶; 69. Williamson⁶, died 27 June 1823, left will 26 Oct. 1822-28 July 1823,⁷⁰ drafted twice and served six months in the Revolutionary War, 1780-81,⁷¹ represented Charlotte County in the House of
