THE GREGORY FAMILY TREE

The first of this family begins with one Richard Gregory, who was born in 1584 and arrived in Virginia on the ship *Temperance* in 1620. Since nothing of a written nature has been handed down, and early Vestry books and Court records have been lost or destroyed little information is available.

Richard Gregory, the immigrant, was first employed by Sir George Yeardley and resided at Flourdieu Hundred in what is now Prince George County (formerly Charles City County). He survived the first great Indian massacre of 1622 and was included in the first census of 1624. It is believed he married in England and had at least one son, Thomas Gregory, who was born in 1620. Richard sent for his son Thomas, who arrived in Virginia on the ship *Globe* out of London in August, 1635. Thomas was fifteen when he arrived in America.

Thomas Gregory (son of Richard) lived in the same section of Virginia as his father. In 1655, the year of his death, he was owner of a plantation and used indentured servants and perhaps share croppers. Thomas married a woman named Jane and at least one son, also named Thomas was born to them in Charles City County.

Thomas Gregory (son of Thomas) was one of the early dissenters from the Established Church and was the overseer of the Quaker Church at Weyn Oke in Charles City. He died about 1720 leaving at least one son, Thomas, who settled across the James River in Prince George County.

Thomas Gregory (son of Thomas, grandson of Thomas, great grandson of Richard). In 1717 Thomas made a purchase of land on the south side of the James River in Prince George County. The Gregory family was from then to live south of the James River, or in what is generally known as southside Virginia for at least the next two hundred and fifty years. He was probably married twice, first to Elizabeth (perhaps Nance) and secondly to Jane __. With Elizabeth he had three children. Nance Gregory, John Gregory b. and Mary Gregory. With Jane he had one child, Lucey Gregory. Thomas Gregory probably died in 1739.

The dates would need to be approximate, but it is believed to be the correct line for the first one hundred years in America. The father, son and grandson, all named Thomas, covered a century or more of the colonial period.

With John Gregory, born on January 1, 1722, there is no doubt of the line to present date.

John Gregory married Mary___ about 1760. In August 1761 he purchased land in Amelia County on the east side of the main Celler Creek. He and Mary Gregory apparently resided on this tract until his early death in 1763. John and Mary had only one child, William Gregory.

Mary, being a widow, then married John Keatts. It is recorded that William Gregory, the orphan of John Gregory, being of age (over 14), came into Amelia County court and chose as his guardian, John Keatts, who was also his stepfather. John Keatts and his family moved from Amelia to Pittsylvania County, and William came with them.

William Gregory probably turned 21 years of age in 1781 and married at about the same time to Martha Tucker, the niece of his stepfather, John Keatts. William bought a small tract of land (66 acres) in Pittsylvania County on the south side of the Banister River. A few years later William, who seemed entirely satisfied with the manner in which John Keatts had settled the affairs of his father's estate in Amelia County, wishing to leave to his mother her portion of the estate, made a deed of gift to his mother's husband certain negroes. A Negro man slave named Timmey, and a certain woman named Lucy and her former increase, Phillis and Tener and all their future increase.

William and Martha Gregory lived on the north side of Banister River, toward the headwaters of Stinking River. William had acquired considerable land. His life was short, he died in the winter of 1800 at about the age of forty years, and before he was able to accumulate much to leave his family. William and Martha, as previously stated, married in 1781, and William died in 1800. In those nine years, they had nine children. John K. (probably Keatts) Gregory, Polly Gregory, Robert T. Gregory, William Gregory, Patsy Gregory, Lowry Gregory, Elizabeth Gregory, Richard Dennis Gregory, and Nancy Gregory. All of

these children were under age at the time of their father's death. Richard Dennis was perhaps two years of age, and his sister Nancy may have been born after her father's death. Being left a widow with nine children, presented quite a challenge to the Martha, but she appears to have managed. As the first born sons reached adulthood, they took over the operation of the plantation, which Martha had managed with her slaves since her husband's death.

Martha Tucker Gregory died in 1812. Four of her children were still under age at that time, so guardians were chosen or appointed for them. Elizabeth and Nancy went with their sister Polly and her husband William Payne. Lowry and Richard Dennis went with their brother John K. Gregory and his wife. The other children, John K., Polly, Robert, William, and Patsy were all of age. Most were married or old enough not to need guardians.

With both father and mother gone, the older children now desired a division of the estate. At the time of Martha Tucker Gregory's death, the estate owned nine slaves; Toomber, Phillis, Tom, Jerry, Jordan, Martha, Binney, Olive, and Pleasant. These were given one to each of the nine children. Robert received Toomber, William received Phillis, Polly received Tom, John K. received Jerry, Lowry received Jordan, Elizabeth received Martha, Patsy received Binney, Nancy received Olive, and Richard Dennis received Pleasant.

The land of the estate was also divided: John K. received 75 acres, Robert received 29 acres, Patsy received 79 acres, William received 80 acres, Lowry received 81 and one half acres, Nancy received 80 acres.

A second tract of land containing 320 acres lying on Reed Creed in Pittsylvania county was divided as follows: Polly received 114 acres, Richard Dennis received 103 acres, and Elizabeth received 103 acres. With the completion of the division of the estate, each child received his share and was satisfied.

From this point on I will deal only with the direct line of Illy Spencer Gregory. This would be Richard Dennis Gregory. Those wishing to read the complete history may borrow our book or get their own from: H.E. Howard, Inc.

Richard Dennis Gregory, youngest son of William and Martha Tucker Gregory, was born in Pittsylvania County, Virginia, in 1798. After the death of his father and mother, his oldest brother, John K. Gregory, was appointed his guardian. On the third day of December, 1812, Richard Dennis, age fourteen, was given one negro slave, Pleasant, who was valued at only twenty pounds. Those brother and sisters who had received more valuable slaves were ordered to pay Richard an amount of money which would place him on the same equal base with themselves. The average value placed on slaves at that time was seventy-two pounds, eight shillings, and eleven pence.

On March 22, 1814, the land belonging to his father's estate was divided. Richard, age sixteen, received a farm of 103 acres. Richard lived with his brother John, who managed Richard's farm until he came of age in 1819.

Richard Dennis married Elizabeth H. Pigg, on February 19, 1827. Elizabeth Pigg was born in 1810. She received some education along with her brothers, since her father, felt the need of an education and had provided in his will provision that each of his children should receive "a good liberal English education".

Richard and Elizabeth Pigg Gregory may have resided on the 103 acre farm he had received from his father's estate. If so they only resided there for the first year of their married life, for on November 1, 1827, Richard sold the farm to Reuben Payne, his nephew, the son of his sister Polly and her husband William Payne. The farm joined the 114 acre tract Polly received of the estate.

Elizabeth received 30 and one fourth acres of land and one negro boy, Joe, upon her father's death. This land was also sold. On the same day this land was sold Richard Dennis and Elizabeth bought a 92 acre tract of land from Elizabeth's brother Hezekiah Pigg. In Pittsylvania County on the waters of the Banister River and Puddens Creek. In 1840 Richard Dennis purchased more land a few miles west on the Sandy River and Strawberry Creek which totaled 498 acres, for \$315.00. Later 92 acres of this tract was sold. He also purchased 125 acres on the Sandy River.

Also in 1840, the 92 acre tract of land was sold. The family now consisting of Richard Dennis, Elizabeth and seven children, lived on a portion of the tract just purchased.

Elizabeth often remonstrated with her husband for going security on other people's bonds. In all fairness, it may be said that in the

majority of cases, and they were extremely numerous, he was going security for the stepfather or brothers of his wife. Never did he sign a note for any of his blood relatives, and it must be considered that out of the tender affection he bore for his wife, he constantly exposed himself by accommodating his wife's relatives.

In 1841 Richard went security on a note for his brother-in-law Hezekiah Pigg, a large sum of money for that day. Whether or not Hezekiah was able to meet his obligation is not known. What is known is that Richard sold all 406 acres of his farm. All this land was taken in order to meet the payment on all the notes on which he served as security. The property in the deed of trust was insufficient, thus causing the sale of all his land. It is not known where the family lived for the next few years until once again lands could be purchased.

In April 1847 Richard again purchased land . He purchased 420 acres lying on the Franklin Turnpike, for \$812.00. On this tract of land he built a house in 1848, which was destined to be his home until his death, as well as the home of his son Henry Gregory, who also live here until his death, and is now occupied by his grandson Charles Gregory, the son of Henry Gregory.

Richard purchased and sold additional lands until 1879 at the age of 81.

Previous to 1879 Richard and Elizabeth sought to provide the nucleus of future farms for all their living children. A deed was made to each child. Elizabeth Pigg Gregory died the year following the granting of land to the children and was buried in the family burial plot within a hundred yards of the family residence. The simple stone marking her grave has the following inscription:

Elizabeth H. wife of
Richard D. Gregory
Died August 13, 1873
Age 63 years
Honored, beloved and wept
here Mother lies.

Richard Dennis Gregory during the latter years of his life did not leave his home. During the summer months, he would sit in his doorway and watch passers-by on the turnpike in front of his home. The house

at that time had no porch across the front. He at times wore a beard. He was a man of medium build, rather slender, and of dark complexion and black hair. He was the son of slave-owning parents and was a slave owner himself. He saw his slaves set free, yet continued to be interested in some of them until his death, and his son also administered to the needs of one of the old slaves until his death. He was a kind and considerate master. His dark complexion may have been due to the fact that his mother was connected to the Powhatan Indians through descent from Pocahontas. Some of his descendants were also very dark complexioned.

Richard lived with his son Henry for five years after the making of the deed to his children. He was buried by the side of his beloved wife, Elizabeth. Though one of a large family, he apparently outlived all his brothers and sisters, some of whom had passed away more than fifty years before. The simple stone marking his grave has the following inscription:

Richard D. Gregory

Died July 18, 1885

Age 87

Fond memory clings to thee

Richard Dennis and Elizabeth Pigg Gregory had thirteen children. A brief biography of each. This family was important in the Gregory line and very interesting.

William C. b. 2/16/1828. The oldest child. He died unmarried about 1848 at the age of 20. No reason given. He is buried at Swansonville, Va.

John Branch. This line will be detailed later. This is Illy Gregory's grandfather.

Nathan Lowry b. 12/25/ 1831. Married Polly Bell. Three children: Julia, John, and Nathan. At age 29 entered Company B of the 38th Regiment of Virginia Volunteers, which was formed in his community. This Regiment was a part of Armistead's Brigade, Fourth Huger's Division of Magruder's Corps. It saw action before Yorktown and Williamsburg and in the fighting around Richmond in 1862. It was a part of Pickett's Division in the charge at Gettysburg. Nathan Lowry Gregory was killed in action there on July 3, 1863. He is buried in

Hollywood Cemetery in Richmond.

Wilson Tucker b. 3/5/1833. Married Nancy T. Midkiff. Two children: Henrietta and Thomas. At age 28 entered Company B of the 38th Regiment of Virginia Volunteers, the same Regiment his brothers served in. After serving for about a year and a half, he contracted a disease (not named) and died in Chimborazo Hospital in Richmond.

Richard P. b. 2/4/1835. Richard and Christopher, his brother purchased 105 acres of land on the Sandy River in 1860. These two brothers were very close. Their three older brothers all gone off to war. They were always together, enjoying whatever amusements were available in their community. Richard joined the same Regiment, Company B of the 38th Regiment of Virginia Volunteers, as his three older brothers had joined. He took part in the Seven Days' Battle around Richmond. They were ordered to charge the Federal works at Malvern Hill. During this bloody charge, the Regiment suffered 388 casualties, Richard was among the 252 wounded men, as was Christopher. Richard's wound proved fatal, he died three days later in Richmond. His brother Christopher, so deeply attached to him, sent to his bedside three of the best physicians available in Richmond, but they were unable to save him. He is buried in Hollywood Cemetery, in Richmond. Richard never married.

Christopher C. b. 2/7/1837. Christopher also joined Company B, 38th Regiment of Virginia Volunteers and continued there throughout the war. He was in the Seven Days' Battle that ended Richard's life. He served on Armistead's Staff as a Color Corporal. He was severely wounded while carrying the Colors in advance of the Regiment. He was cited by his Major as having won for himself immortal honor; and some "badge of honor" was suggested. However, at the time the Confederacy was not issuing "purple hearts". Christopher continued in the Army and his Regiment participated in Pickett's Charge at Gettysburg, he was wounded three times and two of his brothers killed. He spent a short time at home recovering from his wounds, but returned to the war, serving as blacksmith, until the war was over. After four years in the Army, he returned to assist the family in warding off starvation. Times were difficult in 1865. As previously stated Christopher and his brother Richard purchased land, preparing to follow in the footsteps of their forefathers. The war,

which so often shatters dreams, brought their cherished dreams to an end. Christopher could never settle at anything for very long after the war. He operated a store called an Ordinary on the land he and Richard purchased, from 1867 until 1871, but the land was sold, for Christopher had no heart to continue after Richard's death. His love for his brother and their dreams together ended. He was now the oldest living son. He left Pittsylvania County and went to Patrick County where he married Mary Stuart Shough, the daughter of a Methodist minister. They continued to live in Patrick County the remainder of their lives. Christopher worked at many things, finally ending up as a blacksmith. Christopher and Mary had three sons: Denton, William H. and Edward. They also had three daughters: Bessie, Jane W. and Lucy Elizabeth. He died in 1908 and he and his wife are buried in the Haley family burial plot near Stuart.

Mary A. E. b. 12/16/1841. At age 17 married David C. Keatts. They were first cousins. One daughter Malissa.

Martha A. F. b. 1/20/1841. At age 25 married David T. Eddy, a miller. There were several children (not listed). She and her husband lived in Rocky Mount, VA. She died of cancer.

Doctor James b. 12/17/1842. At age 19 joined Company A, 18th Regiment, Virginia Infantry, Confederate States of America, known as the "Danville Blues". This Regiment participated in some of the bloodiest battles of the entire war, including Pickett's Charge at Gettysburg, in which two of his brothers were killed and another wounded. He survived, but at the battle of Fredericksburg, a bomb exploded destroying his left ear-drum. He also received a wound to his foot.

Following the war, he was unsettled, trying several interests before entering the Richmond Medical College, where he became a dentist. He continued in this practice until he was 83. Most of that time in Rocky Mount, Virginia, but also as a traveling dentist in the counties surrounding Rocky Mount. Doctor Doctor James Gregory never married. He entered Lee Camp Soldiers' Home in Richmond and died there in 1928. He was a fluent, gifted speaker, filled with wit and skilled in his profession. He is buried in Hollywood Cemetery in Richmond.

Larina Catherine (Puss) b. 7/13/1845. At age 28 she married James Pleasant Haley. In 1881 or thereabouts Larina was apparently poisoned by a negro servant which resulted in her death. There were five children: Julia Elizabeth, William Richard, Mary Frances, Catherine and John.

Thomas A. (Tobe) b. 12/7/1847. At the age of 16 he entered Company C, 3rd Regiment of Reserves. There is no record of his military life. After the war he spent time with his brother Christopher in Patrick County. At the age of 31 he married M.A. (Molly) Hyton in Patrick County. There were two children: Annie and Nannie. Molly died and he married Mary Katherine (Kate), aged 18. There were seven children of this marriage: Russell Aubrey, Lewis Howell, Lucille, Lottie, Thomas Hutch, Frank Hyton, and Eloise. Thomas was a successful planter in Pittsylvania County. He died at the age of 89. He is buried in the Gregory burial plot in front of the home of his father Richard Dennis.

Henry b. 4/17/1850. The youngest son of Richard Dennis and Elizabeth. Henry agreed to care for his father as long as he lived and to pay \$240.00 to the heirs of his brothers who lost their lives in the war. In exchange he received 54 acres of land including the residence of his father. He carried out this agreement caring for his father and making sure the children of those brothers received their inheritance. He married Louvina A. Piggy. His children were: Walter, Minnie, Mary Elizabeth, C.D. (Dennis), Roxie Ann, Fannie W. and Charlie. Henry died at age of 80 and is buried in the family plot with his father and brother.

Bettie. She is mentioned only once. She received her equal portion of land, 39 and one fourth acres in the deed Richard Dennis and Elizabeth made before their deaths. She is listed as Bettie Cook, but there is no record of her birthdate, marriage or life.

Elizabeth Piggy Gregory was deeply interested in the Confederate Cause. She urged all of her sons to enter the service of the Confederacy who were of age; and as each one became old enough to serve, he went with his mother's blessing. Thus all her sons above

the age of sixteen, seven in number, entered the Confederate Army. Four gave their lives in the defense of their country. Probably no family was more patriotic, and few gave so much.

It is recorded that during the years of the war. Richard Dennis and Elizabeth sold land in order to send money to their sons in the Army. Before their deaths Richard and Elizabeth sought to provide the nucleus of future farms for all their living children. Each were given 39 and one fourth acres of land. As previously stated Henry bought additional land. Of the land that Henry did not buy, certain lands were allotted to the heirs of the sons who died in the war. These heirs were: John Branch's four children to be mentioned later; Nathan Lowry's children Julia , John and Nathan; Wilson Tucker's children: Henrietta and Thomas. Nine children left fatherless.

We now return to the John Branch Gregory

The second son of Richard Dennis and Elizabeth Pigg Gregory was named John Branch Gregory. He was born in Pittsylvania County on December 15, 1829. He married Martha Janes Eanes. Four children resulted from this union. Octavia Clement, John Richard, Delilah Alice, and Algenia Ellen. John Branch was named for his two grandfathers, John Eanes and Richard Gregory.

John Branch voted for the Ordinance of Secession at Whitmel, Va., and having done so was not one to stand idle while others fought. Although over thirty years of age, married and the father of four children, he entered Company D (Whitmel Company) of the 38th Regiment of Virginia Volunteers, which was being organized early in 1861. The Regiment saw service in the hardest engagements of the entire War. it was a part of Pickett's Division, and distinguished itself with this Division in their immortal charge at Gettysburg, in which John Branch was killed in action.

John Branch (called Branch) at the age of 22 had married and purchased a small farm. He purchased 77 acres on Sandy River, and started to follow in the footsteps of his father. He had accumulated little when he joined the Army, giving his life for his country. He lies buried in Hollywood Cemetery in Richmond.

The property belonging to the estate sold for \$222.00.

The widow Martha Jane Eanes Gregory, having four children to raise, married Ralph B. Prewett (Rafe) in 1869.

John Richard Gregory, the son of John Branch and Martha Jane Eanes Gregory, was born in 1854. When John was nine years of age, his father was killed in action in Pickett's Charge at Gettysburg. When he was fourteen his mother remarried. At age sixteen, the court appointed James D. Blair his guardian, as well as guardian of his three sisters who were younger than John Richard. Why Ralph Prewett, his stepfather, was not named guardian is not known. Provision was made for property to fall to John and his sisters by both his paternal and maternal grandfathers. At the age of 21 John Richard received 200 acres of land from John Eanes, Senior. This land lying on the Sandy River was for all four children, about 50

acres each.

Early the next year, John Richard joined his mother and sister Octavia, in the sale of the land left by his father, which was sold to John Covington. At the age of 21, he received his part of his father's estate.

At the age of 31, upon the death of his grandfather, Richard Dennis, he received 41 acres of land lying on the Danville and Fincastle Turnpike. In addition, he received his share of the \$240.00 in cash to be divided among the children whose fathers had died in the war. At the age of 32 John Richard Gregory married Julia A. Hundley, aged 27. They married on May 20, 1886. The following year John Richard Gregory deeded to his wife all of his interest in the land which had been bequeathed to the four children of John Branch Gregory by their maternal grandfather John Eanes, Senior. He likewise deeded to her all of his interest in the land bequeathed by his paternal grandfather, Richard D. Gregory and well as certain other personal property. It would appear from this deed, that no division of the land had been made at this time. It is stated in the deed these provision were made against all future contingencies and for her maintenance and support and that she should enjoy the proceeds, rents, issues, and income of the real and personal estate hereinafter during the term of her natural life or widowhood after the decease of the said John Richard Gregory, and free from the control, liabilities, or interferences of any husband that she now has or may hereafter have. John Richard was a farmer and tobacco grower in Pittsylvania County. The date of the death of John Richard and Julia Hundley Gregory is not recorded, nor the place of their burial. Perhaps someone in the family has this information, Only one child is mentioned, Oakley. We know that there were three sons. Oakley, Lester and Illy. And that brings us to the life of Illy Spencer Gregory.

Illy Spencer Gregory . b. 5/28/1889. He married Mary Hankins. The only information I have is that during the Great Depression Illy lost his farm for a debt of \$600.00 which he had borrowed for his tobacco crop. The crop failed, he lost the farm and moved to Danville, where he work in Dan River Mills. Mary suffered from cancer of the

stomach for many years until her death. The family lived on Piney Forest Road where Hardee's stands today. Illy died April 5, 1980 at his home on Piney Forest Road. He and Mary are buried in Highland Burial Park in Danville, Virginia.
