There was a Drury in Henrico as well, and it could be that they married there, but those records destroyed by Tarleton in Rev. War.

These children are listed in St. Peter's parish. there could be others is they moved and records lost or others in another parish. There is no record of death for Richard or Martha in St. Peter's parish.

It is possible that Drury Scruggs son of Drury Scruggs and Mary is not the Drury that died in TN, as he is not mentioned in his mother's 1803 will. On other hand she may have already given him his due and since he had left for parts unknown, she didn't provide in will for him. She doesn't mention others sons John, Carter (who I assume died), Theodorick or daughter Jane.

It is also odd that only some of Drury's children moved on with him or he with them as he was fairly elderly at the time of the 1850 census. It appears he moved approximately 1820's with some children possibly preceding him. We also know that his Drury did not follow him to TN but remained in Pittsylvania Co, so I doubt that the info on this person's death is accurate, and perhaps he is another Drury, of which there were many. BUT the names fit and it is how it is given in Dunklin's Scruggs Genealogy. Langhorne did go to TN as did Gross, so perhaps he was just mentioning Drury who remained behind in VA.

Note. The warrants were placed in the hands of Samuel Taylor as receiver, to await any action on the part of Timothy Scruggs, or pssiblility of reversal of the court's desision. The above court order was certified as true copy by william G. Sands, Clerk of thesuperior court 1 aug 1844. Certified as truee copy on file in Genl. Land Office, Thos R. Blake.

ON Apr. 15, 1843, asked that his pension be trnasferrd fromVA to MO because he was no a redisent of the State of Missouri and intended to remain there, as his children were caring for him. Within a few years Timothy moved on to campbell Township in Greene Co. In 1850 cnnsus for Greene Co, he was living with his son Timoth Jr. and family. The area where Timothy Jr. setlled later became a part of Christian Co. Cabin was still standing and inhabited by descendant until 1950.

This James Scruggs was married to Hannah Allen. Besides William, they had sons Valentine and Allen. James was definitely the grandfather of Finch Scruggs, who m Nancy Thomas — no doubt there. And James' father was a William Scruggs.

My knowledge of the Scruggs family is based on two pieces of paper: an old letter written by Thomas Baber, grandson of Thomas Baber & Mary? Hutchison,

in 1869, and a lawsuit involving the heirs of William Baber, s/o Mary? Hutchison & Thomas Baber. William, of Mecklenburg Co., VA, died ca 1833 without wife or children and his heirs were his Baber nieces & nephews, Scruggs half brothers & sisters, or their children -all named. The Thomas Baber letter says William Scruggs had a son Finch, and the lawsuit doesn't name him. Did the clerk err? Finch who m Nancy Thomas lived a long while after 1833 and should have been in that lawsuit. So there I sit - was he or wasn't he? Ever hear of these Scruggs?
