

THE WELL DRESSED MILITIAMAN

The following loose paper was found in a file box marked Miscellaneous Papers, District Court, in the Circuit Clerk's Office of Accomack County, Virginia.

Ordered that the uniform of the Infantry of the 2nd Regiment be a blue coat lapelled with scarlet cuffs and cape edged with white lining white buttons and white Epaulett, three buttons to each cuff and four to each pocket flap, pocket to be inside white waistcoat without Skirts, white Pantaloons for Captains & subaltern, white waistcoat & breeches for field Officers and boots with red Tops, cocked hats for all the Officers with black Cockaids. Dated 5th day of Augt. 1799.

SOME VIRGINIA REVOLUTIONARY SOLDIERS

Not all Revolutionary soldiers who were living in 1818 when the first of the general pension laws was enacted made application for government assistance. Nor was this true in the case of some who were living after the more liberal Act of 1832 was passed. The following thirty-four Virginians are among those who do not appear in the Index of Revolutionary War pension applications. Eleven were living veterans who exchanged their Bounty Land Warrants between 1833 and 1836 for scrip which could be used at any land office for land in Ohio, Indiana and Illinois. The other twenty-three were veterans who assigned their Warrants to someone else at some date before 1850. It is not shown whether the latter were alive in 1830.

These names will be found in Volume NN of the old loan records of the Treasury Department, now in the National Archives. The veterans from Virginia who left heirs have appeared in The Virginia Genealogist, volumes 1 and 2.

THE BOOKER FAMILY:

ADDENDUM

Additional information relating to the family of one of the children of James Booker and his first wife (Elizabeth Hubbard?) has been located since the article "The Booker Family of Petsworth Parish, Gloucester Co., Va., and South Farnham Parish, Essex Co., Va.," which appeared in this magazine, v. 5, pp. 51-64, was prepared for publication.

13. Mary Booker (James 3, James 2, --- 1), born say 1746/7, married William Shapard (Sheppard), son of Samuel and Mary (Kavanagh) Sheppard and grandson of Robert and Jessica (Hubard) Sheppard. His brother Samuel Sheppard refers to him only as "my brother William who moved to North Carolina" and gives no further information. 12 Oct. 1762 "William Shepherd of the County of Essex" bought a tract on the branches of Green Creek in Cumberland Co., Va., bounding on the land of John Woodson, from one Thomas Wright. On 27 June 1785 "William Shapard and Mary his wife and Samuel Shapard of the County of Cumberland" sold this tract to Richard Wilson.3 Thereupon William and Mary with the bulk of their family moved on down to Granville Co., N.C., and settled near Mary's sister Amy (Booker) Webb.4

Mary (Booker) Shapard appears to have lived to participate in the move to North Carolina, but apparently predeceased her husband by a number of years. She failed to relinquish dower in any lands sold by him from 1799 on. William Shapard died intestate in Granville County sometime between 2 Feb. 1807, when he was grantor in a deed, and 20 Feb. 1808 when his administrator Francis

Royster sold his "last known property."5

Despite the fact he left no will, he did on 2 Feb. 1807 make its practical equivalent, a deed of all his

property to trustees Thomas Shapard and Francis Royster in return for an annuity to be provided each Christmas by his children: "Samuel, Mildred, William(s?), Elizabeth Royster, James, William Lewis, Thomas, Mary, John, Anne, Barnett and Robert." The punctuation in this list of children is seemingly very careless and consequently misleading.

Issue of William and Mary (Booker) Shapard, probably virtually all born in Cumberland Co., Va. (Shapard was the definite preference in spelling of this branch of

the Sheppard family):

i. Samuel B. Shapard, born say 1763.

- ii. Mildred Shapard, born say 1765. It seems probable that she is the Mildred Shepard who on 18 Dec. 1786 in Cumberland Co., Va., married Anderson Williams, despite William Shepard's assertion that she was the daughter of Samuel.
- iii. Elizabeth H. Shapard, born say 1768, married (date of bond) 6 May 1789 in Granville Co., N.C., Francis Royster. Royster's will, made 26 May 1818, was probated at May Court 1820. His widow Elizabeth dated her will 13 Nov. 1840; it was proved at August Court 1842. iv. James Shapard, born say 1770.

v. William Shapard, Jr., born say 1773.

vi. Lewis Shapard, born say 1775; in 1806 was of Caswell Co., N.C.

vii. Thomas Shapard, born say 1777, married 1811
Fanny Bailey of Person Co., N.C. They resided
in Person County for many years and then migrated to Tennessee, settling near Memphis.

viii. Mary Shapard, born say 1780.

ix. John S. Shapard, born say 1782, married 1808, Person Co., N.C., Elizabeth Vass, daughter of Philip and Elizabeth (Webb) Vass. They resided
