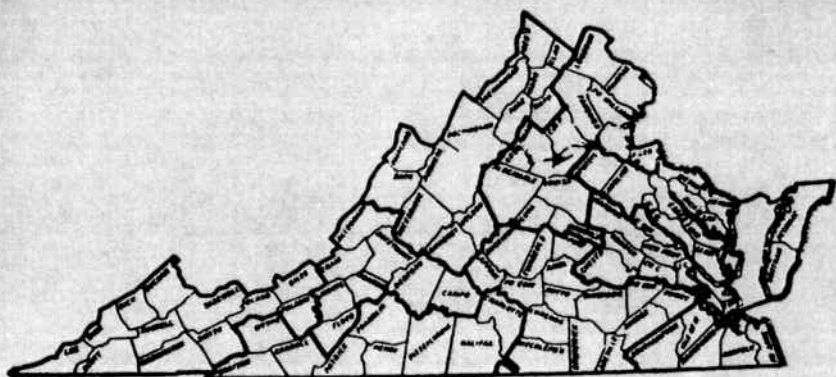

6 June 1767. Order for attachment of £32 and costs against estate of Turner Hunt Christian at suit of Patrick Coutts, assignee.

Mr. John Hardyman, orphan, to Hardyman and Willcox. Account of purchases from 12 Oct. 1767 to 21 Oct. 1770.

5 Aug. 1767. Letter of Nichl. Holt to Mr. Starke, attorney at law, regarding a possible suit of Mr. John Carter in Williamsburg unless Holt gives security. He has already given Turner Christian for security.

1 June 1768. Pinkaman Perry gives promissory note to John Armistead for £2.3.-.

Pinkaman Perry

Wit: Jeremiah Vaiden.

14 March 1771. Summons to Pinkethman Perry to appear in April to answer suit of John Armistead for £4.6.-. Signed by Mordecai Debnam, Clerk.

8 March 1770. Promissory note of John Hardyman of Charles City County to John Christian of same. For £10 for hire of a Negro.

8 Oct. 1771. Account of sales of estate of Capt. Litt^y. Hardyman. To: William Dancy, Col. Benjn. Harrison, William Drummond, John Tyler jr., the Rev. Richard Hewitt and Peter Eppes.

Made by Susanna Hardyman, executrix of the will of her husband.

Sale made 6 Dec. 1771 by William Green Munford and Littlebury Irby, executors: To Litt^y Irby, William Gregory, John Tyler Jur., Peter Royster, John Tyler, Stith Gregory, Saml. Harwood Jr., Philln. Edmondson, Wm. Torborn, Willm. G. Munford, Wm. Acrill, Silvanus Gregory, James Bradley, Wm. Dancy, John Bowry, James Clark, John Hague, Peter Eppes, John Minge, Wm. Ladd, Andrew Crew, Mrs. Hodges, Robt. Walker.

Sale continued 19 [Dec. 1771] by William Green Munford, surviving executor: To John Shearman, Thomas Holt, Geo. Barnes, Char. Christian, Jesse Ladd, Wm. Colier, Purkins Thompson, Saml. Major, Stith Hardyman, Frans. Irby, Edward Maynard, John Colgin, John Christian, William Royal, William Royal junr., Benj. Crew, James Binford, John Crew Easton, Archs. Mitchell, Tho. Holt, Wm. Gill, Major Willcox, Jesse Bradley, Thes^d. Carter, Frances Willson, James Clark.

Nicholas Holt and Sarah his wife, one of the daughters of Samuel Gregory, late of Charles City County, Samuel, Martha and William Holt, children of said Sarah and grandchildren of said Samuel Gregory, infants under 21, show that Samuel Gregory died 1768 seized of considerable estate, leaving a will which left slaves to his wife Elizabeth for life or widowhood and after her death or marriage to the children of Sarah and son William Gregory. He named Elizabeth and son William executors. They rendered no account. In April last [1771?] Elizabeth Gregory married Theodorick Carter of this county and he possessed the estate. William Holt has two children, Samuel and Elizabeth.

June 1771. Estate ordered to be divided.

6 June 1771. Order to summon Philip Par Edmondson, Gent., and Elizabeth his wife, administratrix with the will annexed of William Cole, deceased, John Hardyman and Benjamin Harrison, Gent., Stephen Bowry and Mary his wife administratrix &c of John Sherman Gregory, deceased, and William Christian, executor &c of John Christian, deceased, to answer a bill in Chancery exhibited against them and John Minge, Gent., by William Cole.

May [1772] Abates against Jno. Hardyman and Jno. Minge

Nov. 1772. Da. Minge made a party to suit.

10 Nov. 1772. Summons to David Minge, Gent., administrator with the will annexed of Jno. Minge, deceased, to appear to answer a bill in Chancery exhibited against him.

9 Aug. 1773. Order to Wm. Edloe, Coroner, to summon James Eppes, son and heir of Henrietta Maria Eppes, deceased, to answer William Hardyman, Gent., for a debt of £124.4.0 from 4 March 1771.

4 Dec. 1773. Margaret Kenny of Charles City County for natural love and affection to daughter Jane Kenny.

Two feather beds and furniture, one desk, one corner cupboard, one sealskin trunk, one dozen pewter plates, two dishes, one side saddle, one gray mare, or if the mare is sold, £15.

2 Feb. 1774. Proved by Thomas Bates (a Quaker).

Lewellin Eppes, an infant under 21, by William Hardyman his guardian, shows that Temple Eppes of said county [Charles City] died seized of a considerable estate. Administration was granted Peter Eppes who also died
